MINUTES FROM JANUARY 2016 BOARD MEETING

Call to Order: President Stephanie Miller called the meeting to order at 6:56p.m.

Welcome:

Secretary's Report (October 17, 2015):

Minutes were voted for approval as submitted, which was moved by **Siera Meyer** and seconded by **Kathryn Ballobin**.

Motion passed.

Treasurer's Report (December 31, 2015):

DeLayne's treasurer's report from October 1, 2015 to year-end was reviewed. There has not been much activity during the first quarter of the year. The Certificate of Deposit was also reviewed.

Treasurer's report will be filed as presented.

NDE Update: Rich Katt

Rich shared an update on behalf of NDE, which focused on the current legislation including Perkins reauthorization and ESEA. Regarding legislation this is a short session and many issues currently discussed will not be so focused on education. The State Board of Education election will need to be watched closely and may require member's action.

NDE is currently focused on supporting work-based learning and expanding internships for many schools. A STEM Academy for all teachers to think about teaching STEM-related concepts in all of their classes will be offered this summer. ACTEN members are encouraged to participate or to encourage teachers to attend the Leadership Academy and New Teacher Academy during the last week of July.

2016 NCE Conference Planning: 2015 was the largest ever NCE conference with over 700 participants. Rich shared some new features for the 2016 NCE conference including ACTEN's contributions to the event and Quick Stops mini-sessions. A Quality Rural Education Summit focused primarily on Career Education and teacher-supply will be offered during NCE. Discussions will focus on the recurring issue of maintaining a quality rural education? Keynote speakers include the UCLA Women's Softball Coach on changing the culture of athletics. Dr. Tim Elmore will provide an update on Gen IY. There will be lots of workshops and opportunities! Two 30 Minute Quick Stop Sessions will be reserved for ACTEN. Dr. Sarah Heath, ACTE Past-President will attend and provide a session

on Advisory Councils and during the 30-minute Quick Stop sessions, Sarah will discuss integrating CTSO into the classrooms.

ACTE Update: Stephanie Miller

Career Tech Vision 2015 in New Orleans:

Stephanie Miller, Anne Schmall and Kristin Vest attended the conference as delegates. There was a great delegation of 70 from Nebraska this year. Anne Schmall reported on the session that was presented from Nebraska. It was an excellent conference that certainly makes you grateful to teach in Nebraska! Next year's meeting is in Las Vegas after Thanksgiving.

National Policy Seminar: This will be held on February 29 – March 2, 2016 in Arlington, VA.

DeLayne has been able to attend the last few years and stated that it provides an excellent opportunity to connect with Senator and House representatives. Members that are interested in attending should coordinate their visit with Murleen.

Region V Conference: The conference will be April 20-23, 2016 in San Diego, CA. The flyer will be included in the newsletter. DeLayne will send a check for the Nebraska donation to the Region V fundraiser. Murleen also reported that there is a Best Practices conference opportunity regarding teacher preparation opportunities in CTE.

ACTEN dedicated 30-minute Quick Stop Sessions at NCE conference were the next item of discussion. We would like to involve Dr. Sarah Heath from ACTE, to present a session on incorporating CTSOs in the classroom on Thursday during NCE.

The Strategic Plan will continue to be discussed following NEXUS tomorrow afternoon.

NDE has requested the Proclamation for CTE month from the Governor's Office. Murleen will distribute the NDE Career Education Month resources made available via an e-blast.
